Introduction



About Our Work

Communities In Schools (CIS) is the nation's largest and most effective dropout prevention organization. Our mission is to surround students with a community of support, empowering them to stay in school and achieve in life. Founded in 1977 by Bill Milliken, CIS uses a unique model to unify the existing resources of communities around children, families, and schools. The CIS model utilizes a school-based approach called Integrated Student Supports (ISS), which promotes students' academic success by developing or coordinating supports that target academic and non-academic barriers to achievement. During the 2016-2017 school year, the CIS network operated in 25 states and the District of Columbia, and served 1.56 million students through a federation of 137 organizations including state offices and licensed partners.

About the Data

This Data Book provides an overview of Communities In Schools' affiliate operations and human resources, site-level staff and student supports, as well as student demographics and achievement from the 2016-2017 school year.

Data Sources

Data represents operations during the 2016-2017 school year as reported by CIS organizations and licensees. The sample size for each data point may vary based on available data.

Data Definitions

Adjudicated Youth	A youth who has been found guilty by a judge of committing a delinquent act. The court can commit an adjudicated juvenile or place the juvenile on community control.
AmeriCorps	A program under the Corporation for National and Community Service (CNCS) that engages individuals in intensive service for a year at nonprofits, schools, public agencies, and community and faith-based groups across the country. AmeriCorps members might serve CIS at the affiliate or site level.
Case Management	A collaborative process to 1) establish a system of supports provided to individual students and 2) identify and partner with students at risk of dropping out to: assess their needs and assets; create individual plans; provide, coordinate, monitor, and adjust service delivery; and evaluate student progress against established goals.
Combined School	A school with a population of students falling outside of the typical grade level structure for elementary, middle, or high school (e.g., grades K-8 or 7-12).
CIS Model School	A school with which the affiliate has a formal written agreement to fully implement the CIS model, that is, to provide and/or broker a combination of all tiers of support required by TQS Standards. Student supports are provided based on a comprehensive annual School Support Plan developed and implemented by a designated Site Coordinator who is employed at least half-time.
Community-Based Site	Any location served by CIS that is not a school, such as a community center.
English Language Learners (ELL)	Students who are in the process of learning English. These students often come from non-English speaking homes and backgrounds, and typically require specialized or modified instruction in both English and their academic courses.
Free and Reduced-Price Lunch (FRPL)	Meals provided to students at school through the National School Lunch Program. Income eligibility guidelines are adjusted by the USDA each year.
General Youth Services	Schools served by General Youth Services are those schools where the intention is to implement student, family or school supports without all aspects of the CIS model of integrated student supports. These may be schools where CIS provides only one or more Tier I supports or runs an afterschool program. There may be limited or no case management, no presence of a site coordinator on-site, and/or limited documentation of data and outcomes.
High Risk Behavior	A lifestyle activity that contributes to unintentional injuries and violence, such as sexual behaviors, alcohol and other drug use, and tobacco use.
Integrated Student Supports (ISS)	A school-based approach to promoting students' academic success by developing or securing and coordinating supports that target academic and nonacademic barriers to achievement. These resources range from traditional tutoring and mentoring to provision of a broader set of supports, such as linking students to physical and mental health care and connecting their families to parent education, family counseling, food banks, or employment assistance.
Reassigned Staff	Individuals from a school district or another organization that are not paid directly by CIS but that have been trained to implement the CIS model and operate as CIS staff members.
Saturation Rate	The percentage of the school population served by CIS. Whole-school saturation rate refers to the students participating in whole school supports only. Case-managed saturation rate refers to the students who are case managed by CIS.
Site Coordinator	The CIS point of contact working inside a school to provide integrated student supports. Site coordinators connect students and their families to basic and critical community resources, tailored to students' specific needs.
Site Coordinator Learning Pathway (SCLP)	An online learning path created to increase the knowledge and professionalism of those individuals with the most direct impact on youth, the site coordinators, and to recognize and promote the accomplishments of site leaders.

Data Definitions

Social and Emotional Learning (SEL)	The process through which students acquire and effectively apply the knowledge, attitudes, and skills necessary to understand and manage emotions, set and achieve positive goals, feel and show empathy for others, establish and maintain positive relationships, and make responsible decisions.
Total Quality System (TQS)	A comprehensive set of integrated policies and standards designed to reinforce our commitment to evidence-based practice and accountability throughout the network. These standards are used as a yardstick for continuous quality improvement and growth. The goals of TQS are to promote, replicate and consistently deliver the CIS model and to provide affiliates with the framework for strong, sustainable organizations able to serve students with the CIS model now and in the future.
Whole-School Supports	Supports that are accessible to all students within a school, including students who are not case managed by CIS.



Figure 1. Overall Student Breakdown, by Type of Supports Received





Figure 3. Historical Data: Total Students Served, 1977-2017





Figure 4. Number of Students Served, with 2017 and 2018 Projections³

Figure 5. Known Case-Managed Student **Attributes**




Figure 6. Gender of Case-Managed Students




Figure 7. Free and Reduced-Price Lunch Status of **Case-Managed Students**





Figure 8. Race/Ethnicity of Case-Managed Students







Figure 9. Case-Managed Students Who Met or Made Progress Towards Their Goals




Figure 12. K-11 Case-Managed Students' Year-End Status Breakdown⁵




Figure 11. Grade 12 Case-Managed Students Who Stayed In School⁴





Figure 13. Grade 12 Case-Managed Students Year-End Status Breakdown⁶










Figure 16. School Location Breakdown⁷




Figure 17. School Category Breakdown8

Figure 19. Number of Sites Where Supports Offered, by CIS Support Category





Figure 20. Percent of Sites Providing and/or Brokering Supports, by CIS Support Category9

Figure 21. Number of Sites Offering Supports, by Program Time





Figure 22. Number of Sites Offering Specialized Supports

Figure 23. Number of Sites Reporting Partnerships








Figure 24. Percent of Schools Brokering and/or Providing Services¹⁰

Figure 26. Case-Managed Student Characteristics, by Location




Figure 27. School Type, by Location¹²






Figure 28. Average CIS Model School Saturation Rates, by Location^{12,13}

Figure 30. School Support Staff Gender




Figure 32. School Support Staff Employment Status¹⁵ n=3,041 Full-time: 73.7%

Figure 31. School Support Staff Race/Ethnicity n=2,966





Figure 33. School Support Staff Type

Figure 34. Number of School Support Staff Present at Site, by Percent of Sites¹⁶





Figure 35. Number of Hours School Support Staff Onsite Per Week, by Percent of Sites¹⁶

Figure 36. Site Coordinator Highest Level of Education Breakdown, by Percent of Sites¹⁷





Figure 37. Site Coordinator Presence, by Number of **Sites**



Figure 40. Age Range of Executive Directors




Figure 42. Gender of Executive Directors (EDs)




Figure 41. Race/Ethnicity of Executive Directors (EDs)







Figure 43. Years as Executive Director, by Number of EDs

Figure 44. Employment Status of CIS Affiliate Staff




Figure 45. Race/Ethnicity of **Affiliate Staff** n=1,334 46.2% White 25.9% Black 24.6% Hispanic 1.8% Asian Two or More 1.4% Other 0.1%






Figure 47. Gender of Affiliate Staff





Figure 50. Board Member Breakdown

Figure 51. Affiliate and School Staff, by Employment Status, 2013-2017



Figure 52. Affiliate and School Staff Type Breakdown, 2013-2017



Figure 53. Affiliate Revenue, by Type





Figure 54. Affiliate Revenue, by Source²⁰

Figure 55. Affiliate Revenue, by Funding Type, 2013-2017


